Now, SEBI vide circular No.CIRSD/AML/2/2010 dated 14.06.2010 has informed that, in addition to the obligations contained in the aforesaid Master Circular, the intermediaries are also required to fulfill additional requirements. Point No.5.5(a) of the Master Circular inter alia provides that all registered intermediaries shall proactively put in place appropriate risk management systems to determine whether their client is a Politically Exposed Person (PEP).

In view of above, sub-brokers are advised to inform us latest by 15.07.2010, on the enclosed format, whether any of their client, client's family members or close relatives is a PEP.
